General Information

- All information in this application will be treated confidentially
- All applications must be received at either office of the Garden State Council no later than the close of business on March 31st
- All questions on the form must be completed and should be typed or printed clearly. Incomplete/unclear applications may not be considered
- Camperships are neither transferable nor refundable and have no cash value. Only one campership for each youth member is awarded for a calendar year.
- If the space provided is not adequate to provide all information you believe is important, please attach a separate paper.
- After receiving the campership and attending camp, the Scout should send a thank you letter to the Council Campership Committee Chairman, Garden State Council, 693 Rancocas Road, Westampton NJ 08060

Instructions

1. **Scout & Family Information.** This section identifies the Scout. A separate form should be submitted for each Scout should there be multiple Scouts in the family.
2. **Family Needs.** Please describe the circumstances, including financial matters that require campership assistance for the Scout to attend camp.
3. **Unit Information & Endorsement.** This section helps give the Campership Committee a perspective of the Scout's participation. Attendance, scout spirit, participation in fundraising events, and the effort the Scout puts forth helps give a clear perspective of the Scouts attitude towards the Scouting program. In many cases, the unit may be aware of the financial needs of the Scout, and confirmation of this fact, or further explanation is helpful. Please do not merely repeat information already provided. This section is required.
4. **Summer Program.** This section enables us to identify what Camp/Program the Scout will be participating in to ensure any Campership contribution gets credited appropriately.
5. **Campership Request.** This section helps determine the ultimate campership request. Please remember that camperships are not guaranteed, and it is possible that only a partial campership may be granted. The amount of the campership awarded will be based on financial need as well as the amount of money available to be awarded and therefore may not be for the full amount requested. As a general rule, camperships granted are rarely more than half of the camp fee. Camp fees used in calculations are based only on the most discounted fee. The increased fees are the responsibility of the family/unit.
