## UNIT DEPOSIT ACCOUNT AGREEMENT

- 1. The Garden State Council, BSA agrees to accept a deposit (minimum \$100.00) from any BSA registered Pack, Troop, Crew, Ship, Post or Lab to establish a Unit Deposit Account ("UDA").
- 2. The UDA may be utilized by any authorized adult leader listed below for normal Council-Unit transactions, including supplies, badges, books, awards, uniforms, adult leader training fees, Council Camp fees, District/Council activities and event fees, High Adventure fees (Philmont Contingent, National Jamboree, Sea Base, Northern Tier, etc.), Registrations and Boys' Life. Charges not specified above may be charged at the discretion of the Scout Executive or his designee.
- 3. Units may only add or remove authorized signatories by notifying the Council in writing.
- 4. For each transaction, Garden State Council will provide a written receipt to the person representing the unit showing the dollar amount charged to the unit's UDA and the balance remaining in the account.
- 5. Garden State Council will notify the unit, via the receipt, whenever the unit's UDA balance drops below \$25.00. Additional deposits to the UDA can be made at any time.
- 6. Garden State Council will mail out a statement showing the UDA balance to the unit's Treasurer or Committee Chair for verification of the amount and authorized signatories every March, June, September and December.
- 7. The UDA will be deemed to be "inactive" if no activity has occurred for 180 days or if the unit fails to renew its Charter. Once the UDA is inactive, any remaining funds will be placed in "Funds of Inactive Units." (2782) The Council will hold funds there on behalf of the Chartered Organization for a period of one year. Should the Chartered Organization fail to activate a Scouting program during that time, funds will be turned over to the Council to be used for Scouting purposes.
